In line with this vision, Reach for College (RFC) provides students, teachers and administrators with specialized curriculum and training giving them the tools they need to equip students for further education. These materials walk students through the complex financial aid and applications process; and provide teachers with helpful tools to improve their students' reading and writing capabilities, time management, and study skills to ensure they are ready for college. More recently, RFC has partnered with the College Readiness Institute in Washington, D.C. to host a 4 day event that brings educators in and teaches the concepts of a college going culture. Overall, RFC has had a tremendous positive impact on students in the 5 northeastern states in which they are currently serving. 73% of the students who have used RFC materials have gone on to some form of secondary education, up from just 34% previously. What's more, the number of those who stay in college or are on track to graduate has nearly doubled.
